Elementary School Codes of Conduct/Consequences

This list is not all inclusive and the Administration has the discretion in review of all misconduct and consequences.

Disorderly Conduct (Level I)

Suggested Consequences for Level I

May be an accumulation of any listed offenses

-Tardiness	<u>Category A (up to 5 referrals)</u>
-Cheating/plagiarism	-Loss of credit (cheating, plagiarism & cutting class) and parent contact
-Lying	-Teacher Detention
-Abusive language	-Parent Conference
-Disorderly conduct	-Overnight Suspension
-Forgery	-(1) day out of school suspension
-Cutting class	-opportunity to change attire to meet code
-Dress Code Violation	- Cell Phone Policy applications
-Cell Phone use or Presentation	<u>Category B (up to 6-7 referrals)</u>
-Electronic Device use Including pagers, ipods, cameras, etc. w/o permission	-(1) day out of school suspension; parent/grandparent or Aunt/Uncle over age 21 only may accompany the student all day in lieu of suspension
-out of authorized area	<u>Category C (8 + referrals)</u>
-unauthorized tampering with computers, downloading software, etc.	-(2+) days out of school suspension
	-Create/Review Behavior Modification Plan

Disruptive Conduct (Level II)

Suggested Consequences for Level II

May include any combination within a Level

-fighting/inciting a fight	<u>Category A (1 referral)</u>
-harassment	-Parent Contact
-unauthorized presence on school property/at events	-Create/Review Behavior Modification Plan
-having obscene materials	-Restitution
-leaving campus w/o authorization*	-* (1) day out of school suspension parent/grandparent, Aunt/Uncle only may accompany in lieu of suspension
-deliberate refusal to obey	
-obscene language or gesture	<u>Category B (2 referrals)</u>
-possession of unauthorized substance (Rx, OTC medication)	-Refer to appropriate agency
-any theft or vandalism (<\$50)	-Keep communication item until Sem. ends
-disrupting an assembly	-Restitution
-sexual misconduct / Inappro. messaging (written or electronic)	-(2-3) Suspension days
-possession of any type of tobacco products, lighters matches, rolling papers, or associated paraphernalia	<u>Category C (3+ referrals)</u>
	-(3-5) days out of school suspension
	-“Accompany Plan” in lieu of suspension
	-Parent Pick-Up from School

Disturbing Conduct (Level III)

-Improper sexual conduct / action	-Physically abusing or assaulting staff+++
-Gambling	-Threatening or intimidating school staff+++
-Possession/display of pornographic material	-Bomb Threats+++
-Vandalism / Theft , including computers (> \$50)	-Possession or Use of ANY illegal drugs including alcohol+++
-Cruelty to animals(*) (**)	-Selling drugs or alcohol+++
-Setting off false Fire Alarm	-Extortion(*) (**)
-Possession or transfer of a weapon+++	-Sexual Offenses+++
-Threatening any person with a weapon+++	
-Threatening or intimidating other students	(Weapon/Drug violations are subject to review based on age of the child and weapon involved)
-Setting fires+++	

Suggested Consequences for Level III (May include a Warrant)

-Out of School Suspension (5+) days
-Restitution
- Endangering students/staff (5+) days susp.
-* First Offense Out of School suspension (2+ days) days <u>and</u> mandatory counseling (public or private) – Meeting with a school Review Board before allowed to return
-**Second Offense – Recommendation for Expulsion
+++Mandatory Recommendation for Expulsion
(Any may include Review Board Mtg before allowed to return)
